V. New Business

1. Report on Proposition 218 notices for adoption of construction cost index for water rates

Hearing notice has been sent out to all customers, District has received 15 letters of opposition as of today. Jesus Alonso/Clean Water Action- asked if the signatures from a petition opposing to the water rate increase being passed around town would count. Tom will verify this information with a legal specialist on that area.

- 2. Cannon Engineers Agenda Items
- (a) Consideration of Amendment to Cannon Engineers Agreement for additional engineering services 3<sup>rd</sup> Sewer Relocations Project.

Amando Garza is requesting an additional \$25K for engineering review, there's some work pending on the manholes that still need to be raised and additional work for the sewer grant application.

<u>Motion</u>: Carlos Garcia made a motion to Approve Amendment to the Agreement with Cannon Engineers for an additional \$25,000.00. Pioquinto Garza seconds the motion. All Board Members present in favor, Motion carried. Absent-Ballesteros.

(b) Consideration of Amendment to Wood Rogers Agreement for additional services to the Well No. 3 Project

Sub-consultant has incur additional cost for additional pump testing on wells, and water quality testing for \$12,773.00 (this will come from the 250K district will pay)

<u>Motion</u>: Rosario Velazquez made a motion to Approve Amendment to WoodRodgers Agreement for \$12,773.00. Pioquinto Garza seconds the motion. All Board Members present in favor, Motion carried. Absent-Ballesteros.

(c) Consideration of change order numbers 4, 5, and 6 for Bakersfield Well and Pump

Change order no.4 has cost increase due to inflation \$5,700.00, Change order no.5 scada programming cost is also reflecting inflation \$6,000.00, Change order no.6 modifications on electrical \$7,009.20. These will be covered by IRWMP Grant. Motion: Pioquinto Garza made a motion to Approve Change Orders No. 4, 5 and 6. Rosario Velazquez seconds the motion. All Board present in favor, Motion carried. Absent-Ballesteros.

(d) PG&E Agreement for electrical and transformer upgrade at water treatment plant (funded by grant)

Amando Garza- PG & E needs approval from the District on the purchase agreement for the new transformer of the New Well, this will be paid by Bakersfield Well & Pump under their agreement.

<u>Motion:</u> Carlos Garcia Jr. Made a motion to Authorize Board President to sign PG & E Agreement, Pioquinto Garza seconds the motion. All Board Members present in favor, Motion carried. Absent-Ballesteros.

# (e) CDBG 30.19.01 water treatment booster pump station design amendment

Amando Garza-Initial design fee was \$20K, have almost completed about 60%, I need request to amend the agreement to complete work for additional \$15K. Amando has communicated with CDBG and asked if it's possible to move funds from construction budget to the design budget.

<u>Motion</u>: Rosario Velazquez made a Motion to Approve Amendment to Cannon Engineers, Pioquinto Garza seconds the motion. All Board Members present in favor, Motion carried. Absent-Ballesteros.

## (f) Consideration of change order no. 27 for Specialty Construction

Specialty provided a cost of \$400k but Cannon will need to ask Caltrans for another amendment to cover this additional cost since it is much higher than expected.

<u>Motion:</u> Rosario Velazquez made a motion to Approve Change Order No.27. Pioquinto Garza seconds the motion. All Board Members present in favor, Motion carried. Absent-Ballesteros.
