- 1. Report on USDA Grant/Loan Application for Construction of Office
 - (a.) Application for Funding

Tom: Application is almost done.

(b.) Preliminary Architectural Drawings

Amando Report: Inland Architects completed the preliminary site plan, layout and elevations. These Drawings will be for Kern County CUP. These drawings will be revised when the design phase begins In the future. Kern Co. is currently reviewing the information for the CUP to determine whether a formal CUP process will be required.

(c.) Agreement with SCWA for Environmental Services

Amando Report: Agreement with SWCA are in motion for completion of the environmental documentation required by USDA and by the Kern County Conditional Use Permit Application. Tom: the cost for the Environmental Services Agreement is \$500.00. Motion: Amanda Rollin made a motion to approve payment of \$500.00 to get agreement moving. Pioquinto Garza seconds the motion. All Board members present in favor, Motion carried.

- 2. Report on Widening Hwy 46 through Lost Hills
 - (a.) Letter from County to Acquire Portion of District Property (b.) Letter from County Appraiser Tom-County Public Works Department sent a letter indicating that a portion of the District's Property will be needed for the widening of Hwy 46. Also a letter from an Appraiser hired by the county was received, but before an appraisal of the Districts property can be made the district has the right to hire its own appraiser. Board before we hire an appraiser we would like to see what the County will offer.
 - (c.) Proposed Pedestrian Bridge

Tom- The Wonderful Company is proposing to fund is Pedestrian Bridge on Hwy 46 if approved By Caltrans for the expansion of Hwy 46.

- 3. Consideration of Agreement for Auditing Services From Albert & Associates
 - Tom- Albert & Associates has been doing our audit since Fred past away. This year he has sent in his engagement letter to do this year's audit the total cost will be \$9,700.00. Motion: Pioquinto Garza made a motion to have Albert & Associates perform audit. Emma Clifford seconds the Motion. All Board Members present in favor, Motion carried.
- 4. Development of Airport Property and South of Hwy 46 by Wonderful

- (a) Application for sewer and water service for 21 SFR (b.) Application for sewer and water service for 49 SFR: Wonderful Company purchased the airport property from the County, Wonderful has submitted to applications for service for 21 homes near the airport and 49 homes near the Charter School it would be a total of 70 homes that would need be annexed into the District. Motion: Pioquinto Garza made a motion to approve both will serve letters subject to both properties be annexed into the district. Amanda Rollin seconds the Motion. All members present in favor, Motion Carried.
- 5. Consideration of Revision of Water Well Application to State Revolving Fund
 Tom- We have very low category on this application which makes it harder to obtain. Personel with
 The Wonderful Company took a look at the District application and said it would be better to do a
 grant/loan application so it could give the District a better opportunity to obtain funds but the District
 would need to do a rate increase to some or all customers.
 Board would not like to raise rates. Motion: Vidal Ballesteros made a motion to leave
 application as is. Pioquinto Garza seconds the motion, all Board Members in present in favor. Motion
- 6. Report on Response to Semitropic Water Storage District Basin Sustainability Credit Questionnaire Tom- At last meeting I failed to place this on agenda so I had Ana complete the questionnaire to roll over District's entitlement of 142.54 acers feet of Water with Semitropic instead of cashing out \$6,182.42. Motion: Pioquinto Garza made a motion to approve District entitlement for 142.54 acres of water. Emma Clifford seconds the motion, all Board Members present in favor. Motion Carried.
- 7. Request by Wonderful Company Regarding Booster Pump on Hwy 33 *
 Tom-The District received and e-mail from Dan Lee from the Wonderful Company wanting to know if
 the Booster Pump on Hwy 33 belongs to the District so it could be clean out. I recommended that Ana
 direct him to Phil Nixon co-manager of Berrenda Mesa Water District. Apparently it does appear to be
 District's property as shown in an easement the District has with Berrenda Mesa but we don't use this
 booster pump so the District could reconvey the easement with BM to return the property, and in the
 meantime I would recommend to clean the property.

Motion: Pioquinto Garza made a motion to reconvey the easement with Berrenda Mesa and Authorize Alejandro Ruiz to hire someone to clean the property. Vidal Ballesteros seconds the motion, all board members present in favor. Motion carried.

Motion: Amanda Rollin motion to authorize District Manager to pay plumber no more the \$500.00 in the event this happens again under the same circumstances. Pioquinto Garza seconds the Motion. All Board Members present in favor, Motion Carried.
